1 ballot papers were rejected because votes were given for more candidates than the voter was entitled to vote for

0 o bapurau pleidleisio gan fod modd adnabod y pleidleisiwr drwy rywbeth a oedd wedi'i ysgrifennu neu ei farcio ar y papur pleidleisio

0 ballot papers were rejected because there was something written or marked on the ballot paper by which the voter could be identified

2 ballot papers were rejected because they were unmarked or void for uncertainty
