All admission authorities within Bridgend completed the consultation and determination of admission arrangements for 2023-2024 within the timescale stipulated in the Regulations.

**The following information relates to the local authority's admission arrangements in respect of those schools for which it is the admission authority.**

The local authority's centralised admission process allows greater control and monitoring of the admissions of vulnerable children

For admissions rounds and in-year admissions/transfers processed during the 2021-2022 academic year, looked after children or previously looked after children were prioritised for admission to the school of corporate parent/parent/carer choice. Officers in Pupil Services worked closely with the Education Engagement Team to ensure such pupils were able to access appropriate provision.

All children with a statement of special educational needs (SEN) or a local authority-maintained individual development plan (IDP) were admitted to the placement named on the final statement. All applications in respect of children with additional learning needs but without a statement of SEN or a local authority-maintained IDP were considered in the same way as all other applications, based on the procedures and admission criteria set out in the 2021-2022 School Admissions Policy.

The local authority did not refuse to admit a child on the basis of their behaviour. (This encompasses children considered to be potentially disruptive, exhibiting challenging behaviours or potentially requiring assessment for special educational needs.) The Mainstream Fair Access Panel considered referrals of vulnerable and hard-to place pupils.

The purpose of the Mainstream Fair Access Panel is to consider the most complex individual cases for admission to mainstream places, ensuring that pupils are placed fairly, in schools that can meet their needs, with negative impacts on the effectiveness of education provision both for the learner and the provider being minimised.

The consideration of an individual case by the Mainstream Fair Access Panel may result in reference to the Additional Learning Needs Panel and/or the Access to Education Panel. These panels have a wider remit in respect of vulnerable and hard to place children, most particularly those that may need to be considered for specialist education provisions.

The local authority's oversubscription criteria, applicable in admissions rounds, set out the relative priority of applications in respect of children with medical or psychological conditions, or particular social circumstances (such as young carers). Applications were prioritised under the criterion where the required evidence from a registered health professional was provided (the reasons why the preferred school was considered to be the most suitable school and the difficulties that would arise if the child had to attend another school) and accepted. For in-year admission/transfer applications in respect of such children where there was no capacity in the year group of the requested school, the same evidence requirements and considerations were applied to make a final determination on whether a place would be offered at the requested school.

No applications in any admissions round were received in respect of children who met the oversubscription criterion relating to children of a serving member of UK service personnel or Crown Servant. No in-year admission/transfer applications were received relating to children of a serving member of UK service personnel or Crown Servant.

From April 2022, families began to arrive in Wales from Ukraine under the national scheme arrangements. Welsh Government advised local authorities that the school admissions legislation in Wales, reflected in the statutory School Admissions Code 2013, and on which admission authorities policies are based, applied fully to admission applications in respect of arriving children. Therefore, such applications would have no exceptional status and admission authorities should process and make decisions on the applications as they would for all other applications for school places. (This same position applies in respect of children arriving in Wales under the two established refugee schemes for families from Syria and Afghanistan, and also the scheme for families from Hong Kong.) The decisions made by the local authority on applications for school admission, and home-to-school transport eligibility, for children arriving from Ukraine reflected this position.

Following an admission decision, communications with the parent/carer and the school regarding starting arrangements reflected the advice issued by the Chief Medical Officer in respect of health screening under the national pathway established for the families arriving in Wales.

In the period to 31 August 2022, the local authority received 51 in-year school admission applications in respect of Ukrainian children. Of these, 28 were in respect of primary-aged learners (including nursery), and 23 were in respect of secondary-aged learners.

- For the 28 applications in respect of primary-aged learners, 15 were accepted and the learners were admitted to the requested schools. The remaining 13 were refused due to there being no places available in the relevant year groups at the requested schools. Alternative schools were offered and in 9 instances, the alternative schools were accepted. In 3 instances, parents

applied for and were offered places at voluntary aided schools. One application that had to be refused was in respect of a Full-time Nursery child and the parent made alternative arrangements.

- For the 23 applications in respect of secondary aged learners, 22 were accepted and the learners were admitted to the requested schools. The remaining application was cancelled prior to the local authority's decision.

One additional family with school-age children from Afghanistan was re-settled in Bridgend during the 2021-2022 school year. Places were offered for the children at the requested schools.

No additional families with school-age children from Syria were re-settled in Bridgend during the 2021-2022 school year.

The local authority's admission decisions on all applications in respect of Gypsy, Roma and Traveller children took full account of the Welsh Government Circular No: 003/2008 (Moving Forward – Gypsy Traveller Education) and sections 3.25 and 3.26 of the statutory School Admissions Code for Wales, 2013.

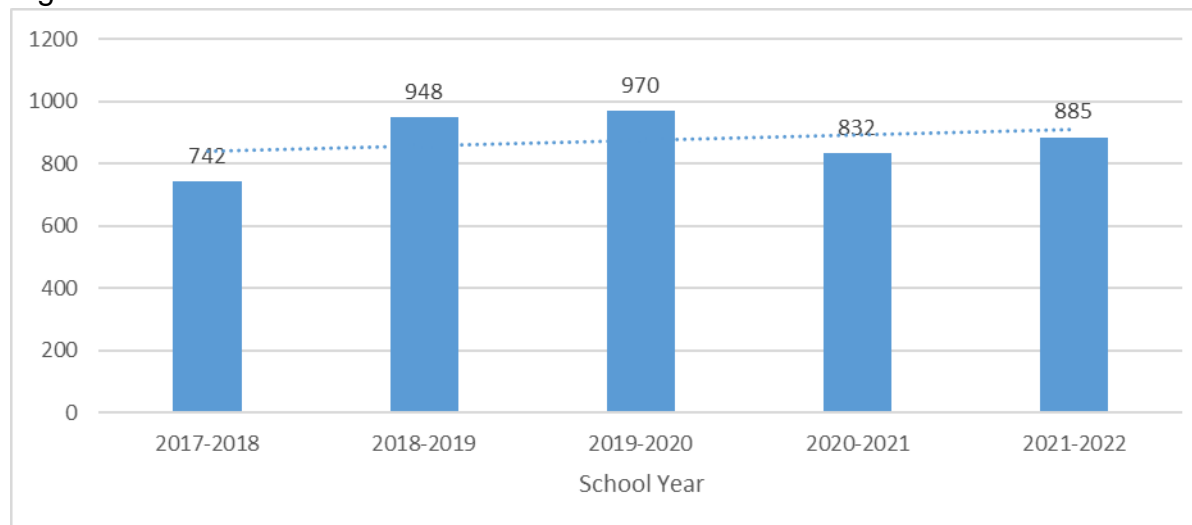
**The following information relates to in-year admission/transfer applications made to the local authority in respect of those schools for which it is the admission authority.**

In accordance with the local authority's published School Admissions Policy, all in-year admission/transfer requests received during the 2021-2022 school year were considered in strict order of date received and against the requested school's published admissions number and the current class structures and numbers. Account was taken of the specific circumstances of the child and family, if appropriate. If a place was available in the relevant year group at the requested school, the place was offered. If no place was available in the relevant year group at the requested school, the application was refused and the local authority advised the applicant/s of the next nearest school with an available place in the relevant year group and the right of appeal (for applications in respect of statutory-age education).

### Mainstream in-year admission/transfer applications in respect of primary-aged children, including nursery

- The number of applications received by the local authority for primary aged-children (including nursery) is detailed in Figure 1. There was an increase in the number of applications received in 2021-2022 compared to 2020-2021, and this would still be the case even if the 28 applications in respect of Ukrainian children were not taken into account. For the five years from 2017-2022, there was a marginally increasing trend in the number of applications received.

- Of the 885 applications received in 2021-2022:
  - 45 (5.1%) were withdrawn before progression to a decision by the local authority. In the majority of these cases, this was due to the application having been submitted too early, per policy, given the requested admission date; the application had been submitted in error, or the application was withdrawn as the child had been admitted to a specialist provision.
  - 643 (72.7%) were accepted for admission to the requested school.
  - 163 (18.4%) were refused for the requested schools, due to oversubscription of places in the requested year groups.

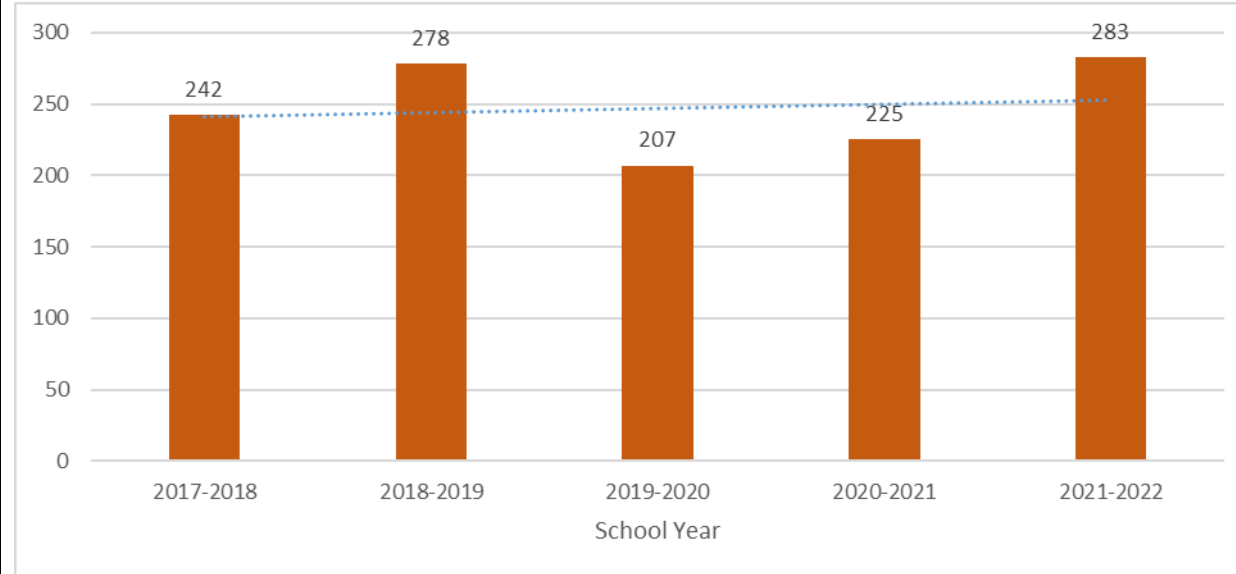


- 34 (3.8%) were refused because admission would result in an infant class size breach.
- For the 197 applications that had to be refused, an alternative school was offered in respect of 118. For the remainder, an alternative school was not offered as either the learner was already attending the nearest alternative school, or the parent/carer had advised that no alternative school would be considered.
- In 2021-2022, the local authority reported a surplus capacity of places in primary schools, for Reception through to Year 6, of 9.43%.

### **Mainstream in-year admission/transfer applications in respect of secondary-aged pupils, Years 7 to 11**

- The number of applications received by the local authority for secondary-aged pupils (Year 7 to Year 11) is detailed in Figure 2. There was an increase in the number of applications received in 2021-2022 compared to 2020-2021, and this would still be the case even if the 23 applications in respect of Ukrainian children were not taken into account. For the five years from 2017-2022, there was a marginally increasing trend in the number of applications received.

- Of the 283 applications received in 2021-2022:
  - 12 (4.2%) were withdrawn before progression to a decision by the local authority. In the majority of these cases, this was due to the application being withdrawn as the child had been admitted to a specialist provision.
  - 249 (88%) were accepted for admission to the requested school.
  - 20 (7.1%) were refused for the requested schools, due to oversubscription of places in the requested year groups.
  - 2 (0.7%) were referred to the Mainstream Fair Access Panel, and subsequently the Access to Education Panel for consideration of specialist provisions.
  - For the 20 applications that had to be refused, an alternative school was offered in respect of 14. For the remainder, an alternative school was not offered as either the learner was already attending the nearest alternative school, or the parent/carer had advised that no alternative school would be considered.
- In 2021-2022, the local authority reported a surplus capacity of places in secondary schools, for Year 7 through to Year 13, of 18%.

**Please provide a short summary of the key admission issues identified for the area and how the forum has addressed them.**

**The following information relates to the local authority's admission arrangements in respect of those schools for which it is the admission authority.**

- **Clarity of oversubscription criteria for Welsh-medium schools.**

The forum noted that a response to the consultation on the 2022-2023 School Admissions Policy was that the oversubscription criteria for Welsh-medium schools were not sufficiently clear. In consequence, separate oversubscription criteria were included in the approved 2022-2023 School Admissions Policy to ensure it was explicit that there are no catchment areas for Welsh-medium schools. The forum did not request any further action.

- **Closing date for the Part-time Nursery admissions round.**  
Some parents had expressed difficulties with the early closing date for the Part-time Nursery admission round and 16% of Part-time Nursery applications for January and April 2022 were late applications. The forum noted that the concern had already been recognised and had been addressed in the 2022-2023 School Admissions Policy in that the closing date for the admissions round, for places in January and April 2023, had been extended from March to the end of August 2022. The forum did not request any further action.
- **The number of available Part-time Nursery places in schools.**  
The forum noted that variation year-on-year is inevitable given the factors that determine the number of such places and that this is explained each year in the School Admissions Policy. The forum noted that if there are no Part-time Nursery places available at a school, but the Full-time Nursery number is low, the local authority consults with the school on whether it is appropriate to convert some of the unfilled Full-time Nursery places to Part-time Nursery places, for that year. The forum did not request any further action.
- **The number of available Part-time Nursery places in Welsh-medium schools.**  
The forum noted that 25 of the 44 applications for places at Welsh-medium school for January 2022 and April 2022 had been refused, due to oversubscription. The forum was assured that the local authority was actively examining means to increase the number of Welsh-medium nursery places for the future and the forum did not request any further action.
- **Oversubscription for Reception places for September 2022 in the Bridgend Northeast area.**  
The forum noted that places at Coety Primary School, Litchard Primary School and Coychurch (Llangrallo) Primary School had, once again, been oversubscribed, evidencing the ongoing pressure on places in this geographical area. Information on the actions either in progress or under consideration in relation to increasing capacity was in the public domain and the forum did not request any further action.
- **Oversubscription for Reception places for September 2022 at West Park Primary School**  
The forum noted that places at the school, in the west of the county, had been oversubscribed, but as there was significant unfilled capacity at the other primary schools in the area, the forum did not request any action.
- **Oversubscription for Full-time Nursery places for September 2022 in the Bridgend Northeast area.**

The forum noted that places at nine English-medium schools had been oversubscribed. The allocation process had been particularly difficult due to the number of oversubscribed schools in the northeast, with many applicants selecting those schools as either a first, second or third preference. Despite oversubscription, overall, just under 96% of applicants received an offer of a place at their first preference school, with 98.7% of applicants receiving either their first, second or third preference school. Information on the actions either in progress or under consideration in relation to increasing capacity in the northeast of the county was in the public domain and the forum did not request any further action.

- **School admissions for children arriving in Bridgend from Ukraine**

The forum received comprehensive information on the handling of applications, the challenges that had arisen and actions taken. Also, the numbers of applications received and outcomes. The forum did not request any further actions.

- **'Virtual' admission appeal hearings.**

The forum noted that the COVID-19 emergency legislation that permitted 'virtual' appeal hearings was to end on 30 September 2022. It was of concern that, after that date, appeals hearings would need to revert to face-to-face, as there was a view that many panel members may not wish to participate in face-to-face hearings any longer. Panel members are volunteers. Not having to travel and being able to participate from home had been beneficial. Prior to lockdown, the local authority has been experiencing difficulties as regards the availability of suitable venues and the expense. The forum also wished to acknowledge that there had been benefits for parents/carers in presenting their cases from the comfort of their own homes. There was general disappointment that these factors, as well as the difficulty with suitable venues and expense, would arise again. The forum supported these factors being reflected in the local authority's response should a proposed Welsh Government survey on 'virtual appeals' proceed.

- **School admission policies of the voluntary-aided (VA) schools**

The forum noted that some of the policies were extremely concise. It was suggested that the VA schools give consideration to adopting sections of the local authority policy each year, to ensure their policies are comprehensive. It was agreed that the Vice Chair of the forum would discuss the matter with colleagues in VA schools and take the opportunity to highlight the consultation requirements upon all admission authorities.
