(30MPH SPEED LIMIT)(50MPH SPEED LIMIT)
TRAFFIC ORDER 2011

NOTICE IS HEREBY GIVEN that the Bridgend County Borough Council (“the Council”) as the Highway Authority for Bridgend intend to make an Order in exercise of its powers under section 84 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Officer of Police and in accordance with Part III of Schedule 9 of the Act the effect of which will be:-

1. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of roads and sides of lengths of roads specified in Schedule 1 to this Notice.
2. No person shall drive any motor vehicle at a speed exceeding 50 miles per hour on the lengths of roads and sides of lengths of roads specified in Schedule 2 to this Notice.
3. A copy of the proposed Order and map showing the lengths of road and sides of lengths of roads to which the proposed Order relates and a statement of the Council’s reasons for proposing to make the Order may be inspected at the address below between the hours of 9.00am to 1.00pm and 2.00pm to 5.00pm Monday to Thursday and 9.00am to 1.00pm and 2.00pm to 4.30pm on Friday.
4. Objections to the proposals together with the grounds on which they are made must be sent in writing to the undersigned at the address below by the 1st day of August 2011.

SCHEDULE 1
(30 MPH SPEED LIMIT)


A4063 (Tondu Road)

- (i) On the northbound carriageway from a point approximately 50 metres (55 yards) south of its junction with the southern side of its signalised junction with the road leading to Penyfai southwards then southeastwards for a distance of approximately 305 metres (333.5 yards)
- (ii) On the southbound carriageway from a point approximately 50 metres (55 yards) south of its junction with the southern side of its signalised junction with the road leading to Penyfai southwards for a distance of approximately 140 metres (153 yards)

SCHEDULE 2
(50 MPH SPEED LIMIT)

A4063 (Tondu Road)

- (i) On the northbound carriageway from a point approximately 355 metres (388 yards) southeast of its junction with the southern side of its signalised junction with the road leading to Penyfai southeastwards for a distance of approximately 743 metres (812.5 yards)
- (ii) On the southbound carriageway from a point approximately 190 metres (208 yards) southeast of its junction with the southern side of its signalised junction with the road leading to Penyfai southeastwards for a distance of approximately 908 metres (993 yards)
