Background and information

This consultation is to invite views on the proposal to discontinue Corneli Primary School and Afon y Felin Primary School and establish a new school with effect from 1 September 2023 and to make a regulated alteration to Ysgol Y Ferch O'r Sgêr in the form of an enlargement with effect from 2 September 2024.

We are consulting with and seeking the views of multiple stakeholders (for a full list see appendix 2). This consultation process will run from 25 January 2021 to 7 March 2021.



The proposal

It is proposed to replace the existing 1 form entry (FE) Welsh-medium primary school that serves the area (Ysgol Y Ferch O'r Sgêr) with enlarged provision, by constructing a new 2 FE school and a 60-place nursery. This will address the need for pupil places and promote growth of the Welsh language. It will eradicate backlog maintenance of £569,254 and provide a 21st century replacement for the dilapidated existing school building, constructed in 1955, which is currently condition category C+ (poor - exhibiting major defects and/ or not operating as intended).

It is also proposed to close and reorganise the existing local English-medium primary schools in the area (Corneli Primary and Afon y Felin Primary) and bring them together on a new school site. The new English-medium school would also have a capacity of 2FE, a 60-place nursery and a 15-place Additional Learning Needs Resource Centre. This would eradicate backlog maintenance of £525,450 in respect of Afon y Felin Primary (constructed in 1977) and £419,030 in respect of Corneli Primary, both of which are currently condition category C+ (poor - exhibiting major defects and/ or not operating as intended).

Construction of the two new schools proposed for the Bridgend West scheme would need to take place in a phased manner. One of the proposed school construction sites is open land on the Valleys to Coast (V2C) 'Marlas' estate, whilst the other proposed site is currently habited by Corneli Primary School, Ysgol Y Ferch O'r Sgêr and the Cornelly Integrated Children's Centre. Consequently, once the first new school is completed on the open 'Marlas' land, the newly established Englishmedium school (replacement for Corneli Primary and Afon y Felin Primary) will need to move into the new building in order to free-up areas of the current Corneli site for the subsequent phased development of the second new school building (the new, enlarged Ysgol Y Ferch O'r Sgêr).



Why has this proposal been brought forward?

On 3rd March 2015, Cabinet approval was received for the Council to adopt revised principles as a framework for school organisation in Bridgend; five key principles were set out to inform the organisation and modernisation of our schools:

- i. Commitment to high standards and excellence in provision;
- ii. Equality of opportunity, so that all pupils can access quality learning opportunities, regardless of which school they attend;
- iii. Inclusive schools, which cater for the learning needs of all their pupils;
- iv. Community focussed schools, where the school actively engages with its local community;
- v. Value for money.

The Policy and Planning Framework sets out 17 areas where the principles should be applied in practice. Those which are particularly relevant in the context of this proposal concern the value for money, efficiency and effectiveness.

The Council have brought forward this proposal to build two new schools in order to:

- provide additional primary pupil places to serve a number of potential local housing developments,
- to address building condition issues, and
- to promote the Welsh language in the Bridgend West area.

The proposed new school buildings would be suitably designed to meet the requirements for the delivery of 21stcCentury teaching and learning.

What the proposal means in practice

The proposal means that the existing local English-medium primary schools (Corneli Primary and Afon y Felin Primary) would close and would be brought together as a newly established school on a new school site (the V2C 'Marlas' site) as from September 2023. The existing catchment areas for Corneli Primary and Afon y Felin



Primary will remain as they are – with the newly established school becoming responsible for both.

The proposal means that the existing local Welsh-medium primary school (Ysgol Y Ferch O'r Sgêr) would be enlarged and relocated as from September 2024 to a new school building constructed on the existing Corneli Primary School/Ysgol Y Ferch O'r Sgêr site.

The Integrated Children's Centre (ICC) building currently located on the Corneli site would remain in situ under the proposal 'as is' and consequently would be adjacent to one of the proposed new school buildings upon completion. Both newly created school buildings would have purpose built integrated community facilities. It is envisioned at this stage that the existing Flying Start provision at Afon y Felin Primary would transfer to the ICC building if the proposal is progressed.

Governing Body

The result of the proposal, should it go ahead, would be that the governing dody arrangements would remain substantially unchanged from current arrangements in respect of Ysgol Y Ferch O'r Sgêr. However, in respect of Corneli Primary and Afon y Felin Primary Schools, the proposal would require the discontinuation of both schools and the establishment of a new school. A new governing body would therefore need to be established in respect of the new school. The new governing body would be responsible for proposing a name for the new school and this would need to be ratified by the Council. The new governing body would also be responsible for establishing the staffing structure and staffing appointment process for the new school.

Staffing Issues

The result of the proposal, should it go ahead, would mean that the staffing complement, except in respect of number of head teachers, should remain substantially as it is, on the basis that there is no projected decrease in number of pupils at the schools. Since the two existing English-medium schools (with two head



teachers) would be replaced by a single school under the proposal, it is likely that the proposal would have an impact in respect of number of head teachers required.

What are the advantages if the proposal goes ahead?

- Pupils and staff would benefit from brand new facilities;
- Savings on repairs and maintenance expenditure of aging school buildings;
- Community provision could be incorporated into new school builds;
- Provision of additional primary pupil places to serve a number of potential local housing developments;
- Promotion of the Welsh language in the Bridgend West area;
- Schools which are designed to provide the right learning environment curricular opportunities particularly at the foundation phase.

What are the potential disadvantages if the proposal goes ahead?

There is an existing hard court pitch and a metal 'container' structure on the land off Gibbons Way at Plas Morlais (owned by V2C) which is located on part of the site required to be developed for provision of one of the new school buildings. Community accessible outdoor sports provision and purpose built, dedicated internal community facilities would be included as part of the proposed new build schemes, which should hopefully negate any perceived detriment involved in developing the site.

Impact of the proposals

Quality and standards in education

Outcomes (standards and wellbeing)

Since their last inspection, standards in Corneli Primary School have improved. Nearly all pupils in both the foundation phase and key stage 2 continue to make



expected levels of progress. Most pupils with additional learning needs and vulnerable learners make good or better progress across the school.

Since their last inspection standards in Afon-y-felin Primary School have improved. Nearly all pupils in the foundation phase and key stage 2 make expected levels of progress and in many cases, progress is beyond expected levels of progress. Pupils with additional learning needs and vulnerable learners make good or better progress across the school.

In their last inspection, Estyn stated that standards in Ysgol Y Ferch O'r Sgêr were adequate and in need of improvement. Since the inspection standards have improved and most pupils now make better than expected progress in the foundation phase and key stage 2. Pupils with additional learning needs perform well across the school enabling most pupils to meet their targets. At foundation phase and key stage 2, pupils eligible for free school meals (eFSM) make very good progress, with no significant gap in performance.

In line with local authority and national priorities, all schools have broadly similar areas for improvement linked to literacy, the development of curriculum for Wales and wellbeing. A larger community setting such as that proposed would not impact on these areas of priority.

Provision (learning experiences, teaching, care support and guidance, and learning environment)

The quality of teaching in Corneli Primary, Afon-y-felin Primary and Ysgol Y Ferch O'r Sgêr is good or better. All schools have well developed processes and systems to help ensure the quality of teaching and learning is maintained. The schools continue to offer effective arrangements to support all learners. All schools make the best of their environments but would benefit significantly from having learning environments designed to facilitate the principles of foundation phase pedagogies as well as support the Curriculum for Wales. Therefore, it is likely that experiences for learners would improve with a modern, purpose-built facility as proposed.



Leadership and management (leadership, improving quality, partnership working and resource management)

In the most recent round of categorisation (September 2019) it was recognised that leadership in all schools was good or better. All schools have well established processes for bringing about improvements. Ysgol Y Ferch O'r Sgêr currently has a significant deficit budget. If the proposed changes were implemented there would be no negative impact on the leadership capacity of the larger setting and the larger site proposed may attract more learners, helping to offset the deficit.

A summary of Her Majesty's Inspectorate for Education and Training in Wales' (Estyn) most recent inspection reports relating to English and Welsh Medium schools likely to be affected by the proposal are included at appendix 1. Welsh in Education Strategic Plan (WESP)

Bridgend's WESP sets out the vision of how we will contribute to the national priority of promoting the Welsh language. In support of this, an objective within our WESP sets out the need to undertake an analysis of demand to help identify the future model for Welsh-medium education within Bridgend. We are now working towards targets so that we are more aspirational about increasing / promoting the language.

This work has determined a strategy for delivering future provision by increasing provision at primary level within the School Modernisation Programme Band B timeframe. In addition, it is recommended that further primary places and greater secondary provision be provided in future Bands of the programme. Additional secondary capacity will be aligned to ensure a continuum of provision. The authority will be undertaken further work in this regard shortly.

This proposal will impact positively on Welsh-medium provision as the project will deliver a significant increase in pupil places for Ysgol Y Ferch O'r Sgêr. It is likely that uptake of Welsh-medium education in the area will increase as a consequence of provision of a 21st century school building – as the extremely poor condition of the



existing building is potentially very 'off-putting' for many parents considering a Welsh-medium education for their children. Additionally, given the very close proximity of the two proposed new schools (the sites selected for each of the proposed new schools are only separated by a road) it is likely that sharing of English-medium and Welsh-medium teaching expertise between the schools would be a simple task.

It is anticipated that uptake of Welsh-medium education in the area will increase as a consequence of the proposal, thereby supporting the authority's WESP targets, promoting the Welsh language and increasing the numbers of non-maintained nursery children transitioning to a Welsh-medium primary education.

Other considerations

The admissions authority for the proposed new school pupils would be Bridgend County Borough Council. Admission arrangements would be as detailed within the Council's 'Starting School prospectus – A Guide to Bridgend Council's Policy & Admission Arrangements for Schools':

The Published Admission Number for the new English-medium school would be 60, the Published Admission Number for Ysgol Y Ferch O'r Sgêr would be 60.

Travel arrangements and accessibility impact

Pupils will be provided with free transport schools in line with Bridgend County Borough Council's school transport policy. Free school transport is currently provided in the County for walking distances greater than 1.5 miles by available walking routes for nursery-aged pupils and for walking distances greater than 2 miles by available walking routes for primary pupils.

The proposed sites for the new schools are less than 0.3 miles away from the current school sites. This is within both the 2 mile and 1.5 mile threshold for school



transport, therefore it is anticipated those currently living directly surrounding the schools could still walk should the proposal be taken forward.

This will also be assessed as part of the transport assessment

Impact Assessments

Community Impact Assessment

An initial community impact assessment has been undertaken and we would welcome your comments/views as part of this consultation as to whether you consider the proposal to have a positive/adverse effect.

The results of the initial assessment is that upon completion of the proposed new school buildings, a positive impact is anticipated as a result of the provision of modern, accessible community facilities.

The initial draft assessment can be found in appendix A.

Welsh Language Impact Assessment

An initial Welsh impact assessment has been undertaken and we would welcome your comments/views as part of this consultation as to whether you consider the proposal to have a positive/adverse effect.

As the proposed new Welsh-medium school would be enlarged and located in a larger, purpose built building, it is considered that there would be a significant positive impact on the Welsh language provision currently experienced by pupils.

The authority will comply with its Welsh language policy by making sure that all signage used within the school sites is bilingual.

The initial draft assessment can be found in appendix B.

Equality Impact Assessment

An initial equalities impact assessment has been undertaken and we would welcome your comments/views as part of this consultation as to whether you consider the proposal to have a positive/adverse effect.



As part of the overall process, the council has a duty to consider the implications of any proposal on all members of the local community who may be affected unfairly as a result of the proposal being carried out. An initial screening has been made of the potential for inequality of opportunity arising from these proposals and it indicates that a full equalities impact assessment will be required in due course. If you have any views on the potential of this proposal to affect any groups or individuals either positively or adversely, then we would welcome your comments as part of this consultation.

Alternatives

Other options to that proposed were considered. Detailed below are a number of options, together with the reasons why these were not preferred:

Continue with the current arrangements

This was discounted principally because this option is not sustainable, does not meet the strategy and aims of the authority and would disadvantage future generations of learners by not addressing the need for 21st century pupil places. It could potentially lead to a shortage in education places due to the anticipated future growth in housing in the area. Schools are currently in very poor condition and don't have appropriate facilities to meet curriculum need.

Welsh-medium

Ysgol Y Ferch O'r Sgêr to Afon y Felin Primary School site (field)

This was discounted principally because the site is too small to accommodate twoschools and the necessary playing fields.

Extension to Ysgol Y Ferch O'r Sgêr and 1FE elsewhere

This was discounted principally because Ysgol Y Ferch O'r Sgêr is currently in very poor condition and doesn't have appropriate facilities to meet curriculum need, so this option would only partially improve facilities, space and potentially outcomes, which have been highlighted as an area for improvement. There is a high risk of limited resources being available due to low pupil numbers in a new 1FE school and this option, in addition to being a relatively expensive one, could create surplus capacity elsewhere which conflicts with WG guidance

Swap Afon y Felin Primary and Welsh-medium (Y Ferch O'r Sgêr) buildings

This was discounted principally because it doesn't increase Welsh-medium capacity and does nothing to address the fact that both existing schools are in very poor condition.



Extend Afon y Felin Primary to create 2FE Welsh-medium school (Afon y Felin Primary to old Y Ferch O'r Sgêr and vice versa)

This was discounted principally because the existing schools are in poor condition and need much improved facilities and space. The maintenance backlog would remain at both existing schools under this option and it would not improve the environment for all learners.

Replacement Y Ferch O'r Sgêr to create Welsh-medium 1.5 FE school

This was discounted principally because it does not entirely fit with WESP and aspiration of growth of Welsh-medium (NB Cymraeg 2050 commitments). In addition, a 1.5 FE school would not be large enough to be a MIM scheme (it would have to be entirely capital funded).

English-medium

Corneli Primary to Afon y Felin Primary (extension Afon y Felin school building)

This was discounted principally because the site is too small to accommodate two schools and the necessary playing fields.

Afon y Felin Primary to Corneli Primary (extension Corneli Primary building)

This was discounted principally because there is a significant backlog of maintenance in both schools which are in close proximity to each other (the existing Corneli Primary building would remain). Although there is no significant immediate pressure on places (although there is likely to be pressure in the future as LDP candidate sites come 'on-stream'), our local strategy does provide for improving the condition of school buildings with new facilities to reduce the dependency on ongoing maintenance work.



Afon y Felin Primary to Pil Primary (new build extension Pil Primary)

This was discounted principally because due to the physical location of Pil Primary in relation to Afon Y Felin Primary, it is highly likely that due to the lack of safe routes to schools, transport costs for learners would be excessive. Pil and Afon Y Felin are not considered to be part of the same local geography as they serve different communities.

Half Pil Primary to Afon y Felin and Corneli Primary respectively

This was discounted principally due to the physical location of Pil Primary in relation to Afon Y Felin and Corneli - it is highly likely that due to the lack of safe routes to schools, transport costs for learners would be excessive.

The projections outlined above do not include for the potential future housing that could be generated by candidate sites submitted for BCBC's new Local Development Plan (LDP) (the projections account only for existing LDP sites with Planning consent). However, it is prudent to consider the future LDP impact when determining the long-term strategy for education in the area. Education and Family Support Directorate officers have determined that a 2 form-entry, Welsh-medium school is appropriate for the Bridgend West area proposal (in light of the demand for pupil places that would be created by potential future housing, the need to promote the Welsh language and to increase the numbers of non-maintained nursery children transitioning to Welsh-medium primary education).

Land and buildings

One site for the proposed replacement schools in Bridgend West has been identified as land at Plas Morlais, owned by V2C. The principle of the proposed land transaction required for the scheme to progress is based upon a 'swap' deal with V2C, whereby BCBC swap the Afon-Y-Felin Primary School site for V2C's Plas Morlais site.

The following table sets out the capacities and an assessment of the quality of accommodation as per the council's Asset Management and Accessibility Plans of the schools identified as being directly affected by the proposal. The capacity calculation is determined as per the Welsh Government Circular No 21/2011 'Measuring the Capacity of Schools in Wales'.

Finance

The anticipated cost of the new schools will be met from the Welsh Government's 21st Century Schools and Colleges Programme utilising the Mutual Investment Model (MIM), for which we have had 'approval in principle', and the Council's capital programme as approved by Council . We will progress the necessary business case



procedures in-line with Welsh Government requirements during the building development and design stages.

If the proposal does go ahead then the cost of the new schools will be funded via an annual charge to the revenue budget, over a 25-year period. Early estimates are that this could be in the region of £500k per annum, but this will be determined as the scheme progresses. The cost is based on a Welsh Government intervention rate for MIM schemes of 81%, with the authority funding 19% of the annual costs, plus 35% of any up-front capital investment for ICT and furniture and equipment.

The running costs of the new schools would be met from within the Delegated Schools' Budget as is currently the case.

Bridgend average per primary pupil funding is £3,637. The current funding per pupil at Corneli Primary is £3,865. The current funding per pupil at Afon y Felin Primary is £4,049. The current funding per pupil at Ysgol Y Ferch O'r Sgêr is £3,915.

The proposal should generate cost efficiencies. The exact amounts are difficult to quantify at present as they will form part of the annual formula funding process.

The consultation process

The consultation process will be completed by 7 March 2021 and the outcomes, which will be incorporated into the proposal where possible, will be reported to a Cabinet meeting on 6 April 2021. Responses to this consultation will not be counted as formal objections, this can only occur during the Public Notice stage as outlined below. If there is a decision not to proceed, that will be the end of this proposal for the foreseeable future and an alternative proposal will need to be sought.

If the decision is to go ahead, a statutory notice outlining the proposal would need to be published for a period of 28 days and any formal written objections would be invited during this time. If there are objections at this Public Notice stage, Cabinet will need to consider the proposal. Cabinet could then accept, reject or modify the proposal. If there are no objections to the proposal, then it will go ahead subject to final approval by Cabinet.

Appendix B - Welsh Language Impact Assessment

Bridgend West

Draft – to be updated following consultation

Proposal to discontinue Corneli Primary School and Afon y Felin Primary School and establish a 'new' school with effect from 1 September 2023 and to make a regulated alteration to Ysgol Y Ferch O'r Sgêr in the form of an enlargement with effect from 2 September 2024.

Corneli Primary School and Afon y Felin Primary School are English-medium primary schools. Ysgol Y Ferch O'r Sgêr is a Welsh-medium primary school.

The Bridgend West proposal involves the construction of two new 21st century schools (one English-medium and 1 Welsh-medium). It is proposed to replace the existing 1 form entry (FE) Welsh-medium primary school that serves the area (Ysgol Y Ferch O'r Sgêr) with enlarged provision, by constructing a new 2 FE school and a 60-place nursery. It is also proposed to close and reorganise the existing local English-medium primary schools in the area (Corneli Primary and Afon y Felin Primary) and bring them together on a new school site. The new English-medium school would also have a capacity of 2FE, a60-place nursery and a 15 place Additional Learning Needs Resource Centre (Corneli Primary's existing provision).

As the proposed new English medium school would provide English-medium education (as Corneli Primary and Afon y Felin Primary currently do), but in a slightly different location (the proposed sites for the new school is less than 0.3 miles away from the current school sites) it is considered unlikely that there would be a significant impact on the Welsh language provision currently experienced by pupils at the school. Welsh would continue to be taught through the curriculum as it is at present.

The proposed new Welsh-medium school (an enlarged Ysgol Y Ferch O'r Sgêr) will be constructed as a new 2 FE Welsh-medium school plus a 60-place nursery. This will deliver a significant increase in pupil places for Ysgol Y Ferch O'r Sgêr. It is likely that uptake of Welsh-medium education in the area will increase as a consequence of provision of a 21st century school building – as the extremely poor condition of the existing building is potentially very 'off-putting' for many parents considering a Welsh-medium education for their children. Additionally, given the very close proximity of the two proposed new schools (the sites selected for each of the proposed new schools are only separated by a road) it is likely that sharing of English-medium and Welsh-medium teaching expertise between the schools would be a simple task. It is anticipated that uptake of Welsh-medium education in the area will increase as a consequence of the proposal - thereby supporting the authority's Welsh in Education Strategic Plan (WESP) targets, promoting the Welsh language and increasing the numbers of non-maintained nursery children transitioning to Welsh-medium primary school.



Both of the proposed new schools (English-medium and Welsh-medium) will incorporate purpose built community facilities. These new community facilities could be utilised in partnership with agencies including 'Welsh for Adults', 'Menter Bro Ogwr' (Bro Ogwr Welsh Language Initiative) and Bridgend College eg for members of the community to learn Welsh, and undertake activities through the medium of Welsh (at either the English-medium school, the Welsh-medium school or both). The authority will comply with its Welsh language policy by making sure that all signage used within the school sites are bilingual.

Summary

The school has a strong Welsh ethos and pupils show pride towards Welsh culture and their local community. On the whole, teaching is sound and teachers provide a wide range of interesting and practical learning experiences for pupils, which engage their enthusiasm towards learning. Many pupils develop to become independent learners. They work well with others and provide their peers with help and support, when necessary. The school's provision for vulnerable pupils is commendable and responds well to their needs. Across the school, pupils are very polite and caring towards each other.

Over the last two years, instability in staffing has limited leaders' ability to address inconsistencies in provision and standards. The headteacher and governors now provide a clear direction for the school's work, the current staffing structure is clear and leaders at all levels fulfil their duties conscientiously. They now use a purposeful range of suitable evaluation activities. As a result, they have increasingly sound knowledge of current standards, which enables them to plan and implement suitable improvements.

Current performance

The current performance of the school is adequate because:

- many pupils make expected and occasionally good progress in relation to their starting points, particularly in their speaking and listening and reading skills;
- many pupils with additional learning needs and free school meal pupils make appropriate and often good progress in line with their age and ability;
- the written work of many pupils is generally well presented; they punctuate their work correctly using appropriate spelling and display good number skills in lessons;
- · pupils' thinking skills are developing well;
- · almost all pupils have high standards of behaviour and wellbeing:
- teachers prepare well for lessons and generally deliver them at a good pace making good use of additional support in class; and
- · pupils with emotional and/or learning needs are well supported.

However:

- very few pupils in key stage 2 write at length or for a range of purposes and audiences:
- in both key stages, the overuse of worksheets means that pupils do not apply their literacy skills well enough across all curriculum areas;
- pupils are generally not confident in solving problems using mental mathematics and do not often apply their numeracy skills well outside of mathematics lessons;
- more able pupils are not always challenged enough;
- the marking of pupils' work is inconsistent and does not often provide clear guidance for pupils on how they can improve;
- the progress that pupils make in speaking and listening, reading and writing in Welsh is not maintained at the end of key stage 2;
- there is no consistent trend of improved performance in the end of key stage 2
 results and too few pupils attain the higher levels in mathematics and science;
 and
- · the curriculum has significant aspects that require improvement.

Report of visit – Afon-Y-Felin Primary School May 2015

Outcome of monitoring

Afon y Felin Primary School is judged to have made sufficient progress in relation to the recommendations following the core inspection in October 2013.

As a result, Her Majesty's Chief Inspector of Education and Training in Wales is removing the school from the list of schools requiring significant improvement.
