NOTICE IS HEREBY GIVEN that the Bridgend County Borough Council (hereinafter referred to as "the Council") intend to make an Order in exercise of their powers under Sections 1(1), 2(1) to (2), 4, 32, 35, 36, 45, 46, 47, 49, 51, 52 and 53 and 124(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended, and of all other enabling powers and after consultation with the Chief Officer of Police and in accordance with Part III of Schedule 9 to the Act of 1984 the effect of which will be to:-

- 1. Amend the BRIDGEND COUNTY BOROUGH COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) (CONSOLIDATION) ORDER 2024, as amended, ("the Consolidation Order") by the revocation of the Order Plans AC63 dated 29/11/2024 and AC64 dated 29/11/2024 and the insertion of the revised Order Plans AC63 Rev 1 and AC64 Rev 1.
- 2. Revoke the Prohibition of Waiting At Any Time restriction set out in **schedule 1** below.
- 3. Designate Residents Only Permit Holders Parking Places under section 45 of the Road Traffic Regulation Act 1984 as set out in **schedule 2** below.
- 4. Introduce Limited Waiting 8am-8pm— 2 hours maximum stay no return within 4 hours (Resident Permit Holders Exempt) restriction set out in **schedule 3** below.
- 5. Introduce a Prohibition of Waiting, Loading and Un-Loading At Any Time restriction as set out in **schedule 4** below.
- 6. Vary the existing Prohibition of Waiting At Any Time restriction to introduce a Prohibition of Waiting Loading and Un-Loading At Any Time restriction as set out in **schedule 5** below.
- 7. Amend Schedule 3 the Consolidation Order to incorporate the streets listed in **schedule 6** below (Zone 2) into the list of those areas subject to a permit fee.

SCHEDULE 1 (REVOCATION) PROHIBITION OF WAITING AT ANY TIME

Sunnyside Access Road

(i) On its northern side, from a point 7 meters (8 yards) west of its junction with Sunnyside Road, for a distance of approximately 28 meters (31 yards) in a westerly direction.

SCHEDULE 2 (DESIGNATE RESIDENTS PERMIT PARKING PLACES)

Cae Dre Street, Bridgend

- (i) On its western side, from a point 6 meters (7 yards) north of its junction with Park Street, for a distances of approximately 16 meters (17 yards) in a northernly direction.
- (ii) On its western side, from a point 41 meters (45 yards) north of its junction with Park Street, for a distance of approximately 15 meters (16 yards) in a northerly direction.
- (iii) On its eastern side, from a point 6 meters (7 yards) north of its junction with Park Street, for a distance of approximately 16 meters (17 yards) in a northerly direction.
- (iv) On its eastern side, from a point 41 meters (45 yards) north of its junction with Park Street, for a distance of approximately 15 meters (16 yards) in a northerly direction.

Sunnyside Road, Bridgend

- (i) On its western side, at its northern termination point, for a distance of 73 meters (80 yards) in a southerly direction.
- (ii) On its western side, from a point in line with the property boundary of 66 and 68 Sunnyside Road, for a distance of approximately 32 meters (35 yards) in a northerly direction.
- (iii) On its eastern side, from a point 2 meters (2 yards) north of the access lane between 45 and 47, for a distance of approximately 52 meters (57 yards) in a northerly direction.
- (iv) On its eastern side, from a point 2 meters north of its junction with Rice Street, for a distance of approximately 31 meters (34 yards) in a northerly direction.

Sunnyside Access Road

(i) On its northern side, from a point 7 meters (8 yard) west of its junction with Sunnyside Road, for a distance of approximately 28 meters (31 yards) in a westerly direction.

SCHEDULE 3 (LIMITED WAITING 8AM-8PM – 2 HOURS MAXIMUM STAY -NO RETURN WITHIN 4 HOURS) (RESIDENT PERMIT HOLDERS EXEMPT)

Cae Dre Street, Bridgend

- (i) On its western side, from a point 22 meters (24 yards) north of its junction with Park Street, for a distance of approximately 10 meters (11 yards) in a northerly direction.
- (ii) On its eastern side, from a point 22 meters (24 yards) north of its junction with Park Street, for a distance of approximately 12 meters (13 yards) in a northerly direction.

Sunnyside Road, Bridgend

- (i) On its western side, from a point 2 meters (2 yards) north of its junction with the access road between 52 and 54 Sunnyside Road, for a distance of approximately 35 meters (38 yards) in a northerly direction.
- (ii) On its eastern side, from a point 12 meters (13 yards) south from the northern termination point, for a distance of approximately 20 meters (22 yards) in a southerly direction.

SCHEDULE 4 (PROHIBITION OF WAITING LOADING AND UNLOADING AT ANY TIME)

Sunnyside Road, Bridgend

- (i) On its eastern side, from its north termination point, for a distance of approximately 1 meter (1 yards) in a westly direction.
- (ii) On its eastern side, from its north termination point, for a distance of approximately 12 meters (13 yards) in a southerly direction.
- (iii) On its eastern side, from a point 32 meters (35 yards) south of its north termination point, for a distance of approximately 26 meters (28 yards) in a south-east, south, south-westly direction.

Sunnyside Access Road

(i) On its southern side, from a point 7 meters (8 yards) west of its junction with Sunnyside Road, for a distance of approximately 35 meters (3 yards) in a westly direction.

SCHEDULE 5 (VARY THE EXISTING PROHIBITION OF WAITING AT ANY TIME RESTRICTION TO INTRODUCE A PROHIBITION OF WAITING LOADING AND UNLOADING AT ANY TIME)

Sunnyside Access Road

- (i) On its north-eastern side, from a point 35 meters (38 yards) west of its junction with Sunnyside Road, for a distance of approximately 14 meters (15 yards) in a north-westerly direction.
- (ii) On its north-western side, from its junction with the Sunnyside Development, for a distance
 - of approximately 8 meters (9 yards) in a north-easterly direction.
- (iii) On its southern side, from its junction with the Sunnyside Development, for a distance of approximately 14 meters (15 yards) in an easterly direction.
