It is proposed to implement the proposal at the beginning of the spring term, January 2025.

In January 2023, the number of pupils at the school was 485, which includes 71 nursery pupils. The pupil capacity of the school for pupils aged from 4 to 11 years of age is 420 places and the proposed capacity once the proposal is implemented will be 525 places.

The admission number for the age group 4 to 5 at the school in the first school year in which the proposals have been implemented will be 75. There will be 75 full-time

nursery places, with 9 full-time equivalent part-time places, providing a total of 84

full-time equivalent nursery places.

## **Explanatory Note**

This proposal involves enlarging Coety Primary School to increase the number of English-medium places available. Increasing the capacity of the school would be achieved by providing a two-storey, four-classroom extension and associated ancillary areas.

The capacity of the school would increase from 420 places to 525 places for 4 to 11-year-olds (that is, 2.5-form-entry school). The nursery will have 75 full-time places, with 9 full-time equivalent part-time places, providing a total of 84 full-time equivalent nursery places.

The new provision would open with effect from January 2025.
