

BRIDGEND COUNTY BOROUGH COUNCIL
(OFF- STREET PARKING PLACES)(CONSOLIDATION) ORDER 2024
(AMENDMENT NO. 1) ORDER 202--

BRIDGEND COUNTY BOROUGH COUNCIL (hereinafter referred to as “the Council”) in exercise of their powers under Sections 32, 35 and Part IV of the Road Traffic Regulation Act 1984, as amended (“the Act”) and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act **HEREBY MAKE THE FOLLOWING ORDER** the effect of which is to amend the Bridgend County Borough Council (Off- Street Parking Places)(Consolidation) Order 2024, (“the 2024 Order”) as follows:-

1. Schedule 1, Column 1, of the 2024 Order is varied by the deletion of the following wording:

Portway,
Porthcawl

and the insertion in substitution into Schedule 1, Column 1, of the 2024 Order, the following wording so that from the date this Order takes affect takes effect the following wording is incorporated into the 2024 Order:

Park, The
Portway,
Porthcawl,
CF36
Plan T1784-07 Rev 1”**

2. Schedule 2, Column 1, of the 2024 Order is varied by the deletion of the following wording:

**“Hillsboro Place
North and
South Car
Parks,
Porthcawl,
CF36
Plan T1784-07”**

and the insertion in substitution into Schedule 2, Column 1, of the 2024 Order, the following wording so that from the date this Order takes affect takes effect the following wording is incorporated into the 2024 Order:

**“Hillsboro Place
North Car
Park,
Porthcawl,
CF36
Plan T1784-07 Rev 1 ”**

3. Revoke the Order Plan specified in Column 1 of the Schedule to this Order and insert the revised Order Plan specified in Column 2 of the Schedule to this Order in substitution.
4. From the date this Order takes effect Order Plan **T1784-07 Rev 1** is incorporated into Schedule 3 of the 2024 Order
5. Save as varied by this Order the remaining provisions of the 2024 Order shall subsist and remain in full force.
6. Insofar as any provision of this Order conflicts with a provision which is contained in an Order made or having effect as if made under the Act existing at the time when this Order comes into operation and which imposes a restriction or prohibition on vehicles in the lengths of roads contained in the Schedule to this Order, that provision of this Order shall prevail.
7. The restrictions prohibitions and requirements imposed by this Order shall be in addition to and not in derogation from any restriction or requirements imposed by any regulations or Order made or having effect as if made under the Act or by or under any other enactment.
8. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
9. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
10. This Order shall come into force on 00/00/202- and may be cited at the Bridgend County Borough Council (Off- Street Parking Places)(Consolidation) Order 2024 (Amendment No. 1) Order 202-


