**AIG WOMEN'S OPEN EVENT – ROYAL PORTHCAWL GOLF CLUB 2025**  
**(VARIOUS ROADS, PORTHCAWL)**  
**TEMPORARY TRAFFIC ORDER 2025**

**NOTICE IS HEREBY GIVEN** that the Council as the Highway Authority for Porthcawl in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) intends in not less than 7 days from the date of this Notice to make an Order which will temporarily introduce the restrictions as well as temporarily implement a reduced speed limit of 20mph as set out in the schedule below.

The Order is necessary due to facilitating the holding of an event and reducing the disruption to traffic likely to be caused by the women's British Open Golf event held at Royal Porthcawl Golf Club, Porthcawl.

The Order will come into force on the 27/07/2025 and will continue in force for a maximum period of 18 months or until such time as the event is completed, whichever is sooner.

It is anticipated the restrictions will occur as follows:

1. Sections 1 – 9(a) from Monday 28th July 2025 until Monday 4th August 2025 between the hours of 06:00am to 21:00pm.
2. Sections 10 - 20 from Monday 28th July 2025 until Sunday 3rd August 2025 between the hours of 06:00am to 16:00pm.
3. Sections 21 - 22 from Sunday 27th July 2025 to Monday 4th August 2025 to be in operation continuously for the duration of the restriction.

**Schedule**

**Sections subject to Urban Clearway Restriction with Tow Away provisions: -**

1. West Road, Porthcawl, from the midpoint of Number 211 / 213 West Road to 5 metres to the East of the junction with Westfield Crescent, Porthcawl.
2. West Road from its junction with the East side of West Park Drive, in an Easterly direction for a distance of 15 metres.
3. Cae Ganol, Porthcawl, from its junction with West Road for a distance of 40 metres.
4. The Retreat, Porthcawl, from its junction with West Road for a distance of 40 metres.
5. Nottage Meadows, Porthcawl, from its junction with West Road for a distance of 40 metres.
6. Nottage Mead, Porthcawl, from its junction with West Road for a distance of 40 metres.
7. Long Acre Drive, Porthcawl, from its junction with West Road for a distance of 40 metres.
8. West Road, Porthcawl, from a point 5 metres to the East of Wellfield Crescent to a point of 5 metres to the East of the junction with West Park Drive.
9. West Road, Porthcawl, from Number 70a West Road to its junction with West Park Drive.
- 9a. Rest Bay access road from Mallard Way, on both sides, from its junction with the entrance to the Royal Porthcawl Golf Club, in a Southerly direction for a distance of 165 metres.

**Sections subject to No waiting at any time Restriction with Tow Away provisions, (Blue Badge Holders exempt up to 3 hours).**

**No person shall cause any vehicle to wait at any time on the following roads and sides of lengths of roads: -**

10. Fulmar Road, Porthcawl, on both sides of the carriageway from its junction with West Park Drive for a distance of 30 metres in a Westerly and Easterly direction
11. On the East side of West Park Drive, Porthcawl, from its junction with Fulmar Road, in a Northerly direction for a distance of approximately 85 metres, and on the West side of West Park Drive for a distance of approximately 33 metres.
12. On the West side of West Park Drive from Number 7 to Number 15 for a distance of approximately 55 metres.
13. On the West side of West Park Drive from its junction with Turnstone Road to a point outside Number 33, a distance of approximately 138 metres.
14. On the East side of West Park Drive from its junction with Rockfields to a point outside Number 46, a distance of approximately 20 metres.
15. On the West side of West Park Drive from its junction with Sandpiper Road to a point outside Number 49, a distance of approximately 38 metres.
16. On the East side of West Park Drive from a point outside Number 62 to a point outside Number 72, a distance of approximately 54 metres.
17. On the West side of West Park Drive from a point outside Number 69 to a point outside Number 81, a distance of approximately 66 metres.
18. On the Southern side of West Park Drive from a point outside Number 90 to a point outside Number 106, a distance of approximately 75 metres.
19. On the Northern side of West Park Drive from a point outside Number 105 to a point outside Number 117, a distance of approximately 75 metres.
20. On the Southern and Northern Side of West Park Drive from its junction with West Road to a point outside Number 72, a distance of approximately 67 metres.

**Section subject to 20mph maximum speed restriction:**

21. No person shall cause any vehicle to be driven at a speed in excess of 20mph from 231 West Road to 103 West Road, a distance of approximately 460 metres. An exemption to the 20mph speed limit will apply to an exempted vehicle.

**Section subject to No Right Turn:**

22. No person shall cause any vehicle to make a right hand turn when exiting from the access of the temporary car park opposite Number 191 / 193 West Road onto West Road.

In this Notice "exempted vehicle" means:

- (a) any vehicle being used by the emergency services for the purposes described in section 87 of the Road Traffic Regulation Act 1984;
- (b) any vehicle being used for naval, military or air force purposes, and being driven by a person for the time being subject to the orders of the member of the armed forces of the Crown, who is a member of the special forces -
  - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
  - (ii) for the purposes of training a person in driving vehicles at high speeds.

“special forces” means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director.

Access will be provided through the restriction for Police, Fire and Ambulance Services responding to emergencies. Pedestrian access to all properties within the restriction will be maintained along defined routes throughout the period of the closure.

The restrictions shall however only apply at such time and to such extent as shall from time to time be indicated by traffic signs prescribed by The Traffic Signs Regulations and General Directions 2016.
