The above Order was confirmed by the Bridgend County Borough Council on the 02/07/2025. The effect of the Order as confirmed is to modify the Definitive Map and Statement for the area by adding to them the footpath from the junction of the maintainable highway at Dale View, Cefn Cribwr, Point A (Grid Reference SS 86418273), and proceeds in a general westerly direction for approximately 34 metres to its junction with Footpath 40 Cefn Cribwr at Point B (Grid Reference SS 86378275).

The order took effect on the date it was confirmed, but if any person aggrieved by the order wants to question its validity, or that of any provision contained in it on the ground that it is not within the powers of the Wildlife and Countryside Act 1981, or on the ground that any requirement of the Act, or any regulation made under the Act has not been complied with in relation to the Order, he or she may, under Schedule 15 paragraph 12 of the Wildlife and Countryside Act 1981, within 42 days from the 10/07/2025 make an application to the High Court.
