BRIDGEND COUNTY BOROUGH COUNCIL(VARIOUS ROADS, BRIDGEND) (PROHIBITION OF ENTRY)(VARIATION)(REVOCATION) ORDER 202-

WHEREAS the Bridgend County Borough Council (hereinafter referred to as "the Council") being the Highway Authority for Bridgend in exercise of their powers under Sections 1 and 2 and Part IV of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police and in accordance with Part III of Schedule 9 of the Act hereby make the following Order the effect of which is:-

- This Order shall come into force on the 00/00/202- and may be cited as the "BRIDGEND COUNTY BOROUGH COUNCIL (VARIOUS ROADS, BRIDGEND)(PROHIBITION OF ENTRY)(VARIATION)(REVOCATION) ORDER 202-"
- Vary the Glamorgan County Council (Various Roads, Bridgend)(Prohibition of Entry) Order, 1973 ("the 1973 Order") so that from the date this Order takes effect the schedule to the 1973 Order shall be amended to remove the lengths of roads detailed in schedule 1 below.
- 3. Vary the Bridgend County Borough Council (Various Roads, Bridgend)(Prohibition of Entry)(Variation)(Revocation) Order 2022 ("the 2022 Order") so that from the date this Order takes effect schedule 2 to the 2022 Order shall be amended to remove the lengths of roads detailed in schedule 1 below
- 4. From the date this Order takes effect the schedule to the 1973 Order and schedule 2 of the 2022 Order shall be construed and read as contained in schedule 2 below.
- 5. Save as varied by this Order the remaining provisions of the 1973 Order and the 2022 Order shall subsist and remain in full force.
- 6. Insofar as any provision of this Order conflicts with a provision which is contained in an Order made or having effect as if made under the Act existing at the time when this Order comes into operation and which imposes a restriction or prohibition on vehicles and or pedestrians in the lengths of roads contained in the Schedule to this Order, that provision of this Order shall prevail.
- 7. The prohibition or requirement imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation or Order made or having effect as if made under the Act or by or under any other enactment.
- 8. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 9. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
