# BRIDGEND COUNTY BOROUGH COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) (CIVIL ENFORCEMENT) ORDER 2013 (AMENDMENT No. 26) ORDER 2023

NOTICE IS HEREBY GIVEN that the Bridgend County Borough Council (hereinafter referred to as "the Council") as the Highway Authority for Porthcawl, have made the following Order in exercise of their powers under Sections 1, 2, 3, 4, 32, 35, 124 and Part IV of the Road Traffic Regulation Act 1984 ("the Act") and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act the effect of which will be to amend the following restrictions in the BRIDGEND COUNTY BOROUGH COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) (CIVIL ENFORCEMENT) ORDER 2013 ("the 2013 Order) as amended, by the revocation of the Order Plans CA12 Rev 2 (Dated:17.11.2021) and CB12 Rev 1 (Dated:10.02.2021) and the insertion of the revised Order Plans CA12 Rev 3 (Dated:14.11.2022) and CB12 Rev 2 (Dated:14.11.2022) the effect of which is as detailed in the schedule below.

The order was made on the **08/11/2023** and will come into force on the **24/11/2023**. If any person wishes to question the validity of any Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act or that any requirement of the Act or of any instrument made under the Act has not been complied with, that person may, within six weeks from the date on which the Order is made, apply for the purpose to the High Court. The council welcomes receiving correspondence in Welsh, any correspondence received in Welsh will be answered in Welsh and corresponding in Welsh will not lead to a delay in responding.

#### **SCHEDULE**

## PROHIBITION OF LOADING AND UNLOADING AT ANY TIME

## **Eastern Promenade**

- (i) On its Northern Side, from its Junction with the A4106 Porthway roundabout, eastwards for a distance of approximately 80 Meters (87 yards), then north-eastwards for a distance of approximately 19 meters (21 yards)
- (ii) On its southern side, from its junction with the A4106 Porthway roundabout, eastwards for a distance of approximately 156 meters (171 yards).
- (iii) On its eastern side, from its junction with the Griffin Park roundabout, southwards for a distance of approximately 135 meters (148 yards).

### **Griffin Park Roundabout**

(i) On its eastern side, from its junction with Eastern Promenade, northwards for a distance of approximately 20 meters (22 yards).
