

BRIDGEND COUNTY BOROUGH COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) (CONSOLIDATION) ORDER 2024
AMENDMENT ORDER NO.2 202-

NOTICE IS HEREBY GIVEN that the Bridgend County Borough Council (hereinafter referred to as “the Council”) as the Highway Authority for Porthcawl, intend to make the following Order in exercise of their powers under Sections 1(1), 2(1) to (2), 4,124(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended, the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police and in accordance with Part III of Schedule 9 to the Act of 1984 the effect of which will be to amend the following restrictions in the BRIDGEND COUNTY BOROUGH COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) (CONSOLIDATION) ORDER 2024 (“the Consolidation Order”), by the revocation of the Order Plan L75 dated 29.11.2024 and the insertion of the revised Order Plan L75 Rev 1, the effect of which will be to introduce a prohibition of waiting loading and unloading at any time restriction detailed in the schedule below.

SCHEDULE -PROHIBITION OF WAITING LOADING AND UNLOADING AT ANY TIME

Ffordd Llyn Halen (Aldi Access Road)

- (i) On its southern side, from its junction with the A4106 Portway Roundabout, in an easterly direction, for a distance of approximately 124 meters (136 yards).
- (ii) On its northern side, from its junction with the A4106 Portway Roundabout, in an easterly, then northerly direction, for a distance of approximately 79 meters (86 yards).
- (iii) On its southern side, at its eastern termination point, in a northerly direction, for a distance of approximately 7 meters (8 yards).
- (iv) On its northern side, at its eastern termination point, in a north westerly direction, for a distance of approximately 46 meters (50 yards).
