NOTICE IS HEREBY GIVEN that Bridgend County Borough Council as the Highway Authority for Pencoed in exercise of their powers under Sections 90(A), (C), (D), (E) and (F) of the Highways Act 1980 and Section 23 of the Road Traffic Regulation Act 1984, the Highways (Road Humps) Regulations 1999 and all other enabling powers and after consultation with the Chief Officer of Police, propose to establish a controlled raised Zebra Pedestrian Crossing as set out in the schedule below.
