The order was made on the 17/12/2025 and will come into force on the 26/12/2025. If any person wishes to question the validity of any Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act or that any requirement of the Act or of any instrument made under the Act has not been complied with, that person may, within six weeks from the date on which the Order is made, apply for the purpose to the High Court. ### SCHEDULE 1 REVOCATION

## 1. REVOCATION OF PROHIBITION OF WAITING AT ANY TIME RESTRICTION Old Station Road, Porthcawl

- (i) On its northern side from a point approximately 5.5 meters (6 yards) northwest of its junction with the western side of Station Close in a north westerly direction for a distance of approximately 9.5 meters (10 yards).
- (ii) On its northern Side from a point approximately 34 meters (37 yards) northwest of its junction with the western side of Station Close, in a westerly then south westerly direction for a distance of approximately 19 meters (21 yards).

## 2.REVOCATION OF LIMITED WAITING RESTRICTION (1 HOUR MAXIMUM STAY NO RETURN IN ONE HOUR-MONDAY TO SATURDAY) (BETWEEN 8AM – 6PM) Old Station Road, Porthcawl

(i) On its northern side from a point approximately 15 meters (16 yards) northwest of its junction with the western side of Station Close in a north westerly direction for a distance of approximately 19 meters (21 yards).

## 1.INTRODUCTION OF PROHIBITION OF WAITING AT ANY TIME RESTRICTION Old Station Road, Porthcawl

- (i) On its northern side from a point approximately 17.5 meters (19 yards) northwest of its junction with the western side of Station Close in a north westerly direction for a distance of approximately 20 meters (22 yards).
- (ii) On its northern side from a point approximately 47.5 meters (51 yards) northwest of its junction with the western side of Station Close in a westerly then south westerly direction for a distance of approximately 5 meters (5 yards).

# 2.INTRODUCTION OF LIMITED WAITING RESTRICTION (1 HOUR MAXIMUM STAY NO RETURN IN ONE HOUR-MONDAY TO SATURDAY) (BETWEEN 8AM – 6PM) Old Station Road, Porthcawl

- (i) On its northern side from a point approximately 5.5 meters (6 yards) northwest of its junction with the western side of Station Close in a north westerly direction for a distance of approximately 12 meters (13 yards).
- (ii) On its northern side from a point approximately 37.5 meters (41 yards) northwest of its junction with the western side of Station Close in a south westerly direction for a distance of approximately 10 meters (11 yards).
