

**BRIDGEND COUNTY BOROUGH COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) (CONSOLIDATION) ORDER 2024 (AMENDMENT NO.1)**

**NOTICE IS HEREBY GIVEN** that the Bridgend County Borough Council (hereinafter referred to as “the Council”) as the Highway Authority for Tondy, intend to make the following Order in exercise of their powers under Sections 1(1), 2(1) to (2), 4,124(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended, the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police and in accordance with Part III of Schedule 9 to the Act of 1984 the effect of which will be to amend the following restrictions in the BRIDGEND COUNTY BOROUGH COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) (CONSOLIDATION) ORDER 2024 (“**the Consolidation Order**”), by the revocation of the Order Plan **AA47** dated 29.11.2024 and the insertion of the revised Order Plan **AA47 Rev 1** and the insertion of the new Order Plan **Z47 Rev 0**, the effect of which will be to introduce a prohibition of waiting loading and unloading at any time restriction detailed in the schedule below.

**SCHEDULE -PROHIBITION OF WAITING LOADING AND UNLOADING AT ANY TIME**

**Heol Parc Tondy, Tondy Bridgend**

- (i) On its northern side, from its junction with the eastern side of Clos Y Cowell in a south easterly direction for a distance of approximately 39 metres (43 yards).
- (ii) On its northern side, from its junction with the western side of Clos Y Cowell in a north western direction for a distance of approximately 7 meters (8 yards)
- (iii) On its northern side, from its junction with the eastern side of the Unnamed Access Road in a south easterly direction for a distance of approximately 13 metres (14 yards).
- (iv) On its northern side, from its junction with western side of the Waste Transfer Station in a north westerly direction for a distance of approximately 63 metres (69 yards)
- (v) On its northern side from the junction with the eastern side of the Waste Transfer Station in a south easterly direction for a distance of approximately 28 metres (31yards).
- (vi) On its southern side, from its junction with the eastern side of Rhodfa Parc Slip in a south easterly direction for a distance of approximately 81 metres (88 yards).
- (vii) On its Southern side, from its junction with Rhondfa Parc Slip in a north westerly direction for a distance of approximately 80m (87 yards).

### **Clos Y Cawell,Tondu, Bridgend**

- (i) On its western side, in a north eastern direction from its junction with Heol Parc Tondu for a distance of approximately 8 metres (9 yards).
- (ii) On its eastern side, in a north westerly direction from its junction with Heol Parc Tondu for a distance of approximately 8 metres (9 yards).

### **Unnamed Access Road,Tondu, Bridgend**

- (i) On its western side, in a north easterly direction from its junction with Heol Parc Tondu for a distance of approximately 8 metres (9 yards).
- (ii) On its eastern side, in a north westerly direction from its junction with Heol Parc Tondu for a distance of approximately 8 metres (9 yards).

### **Rhodfa Parc Slip, Tondu, Bridgend**

- (i) On its western side, in a south westerly direction from its junction with Heol Parc Tondu for a distance of approximately 32 metres (35 yards).
- (ii) On its western side, from a point approximately 43 metres (47 yards) south west from its junction with Heol Parc Tondu for a distance of approximately 3 metres (3 yards).
- (iii) On its eastern side, in a south westerly direction from its junction with Heol Parc Tondu for a distance of approximately 46 metres (50 yards).

### **Heol Y Glowyr, Tondu, Bridgend**

- (i) On its western side, in a south westerly direction from its junction with Heol Parc Tondu for a distance of approximately 8 metres (9 yards).
- (ii) On its eastern side, in a south westerly direction from its junction with Heol Parc Tondu for a distance of approximately 8 metres (9 yards).
