(FOOTPATH 20 PORTHCAWL AND FOOTPATH 55 CORNELLY)
TEMPORARY CLOSURE ORDER 2025

NOTICE IS HEREBY GIVEN that the Council as the Highway Authority for Porthcawl and Cornelly in exercise of its powers under Section 16A of the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers intends in not less than 7 days from the date of this Notice to make an Order which will temporarily close the footpaths set out in the schedule below.

Consent has been obtained under authority of the Cabinet Secretary for Transport and North Wales, one of the Welsh Ministers, to the making of the Order in accordance with 16B(1)(b) of the Road Traffic Regulation Act 1984.

The Order is necessary to allow for a secure perimeter during the AIG Women's Open Event taking place at Royal Porthcawl Golf Club, to maintain the safety and security of the public, high-profile professional athletes and those attending the event.

Schedule – Footpaths subject to Temporary Closure

The restriction commences at the junction of Footpath 20 and 22 Porthcawl (Point A Grid Ref. SS 79627 79282) and proceeds on Footpath 20 Porthcawl in a general northeasterly direction for 66 metres to the junction of Footpath 55 Cornelly, then continues along Footpath 55 Cornelly in a general easterly direction for 1028 metres where it rejoins Footpath 20 Porthcawl (Point B Grid Ref. SS 80676 79326).

The Order will come into force on the 30th July 2025 and will continue in force until and including the 4th August 2025.

The restrictions shall however only apply at such time and to such extent as shall from time to time be indicated by traffic signs prescribed by The Traffic Signs Regulations and General Directions 2016.

The alternative route is via Footpath 20 Porthcawl, Footpath 55 Cornelly, West Road, Anglesey Way, Footpath 1 Porthcawl, Locks Common cycle path and Footpath 22 Porthcawl.
