SS 8493 9169) and proceeding in a general northerly direction for 32 metres to Point D (Grid Ref. SS 8494 9172), then proceeding east northeast for 70 metres to Point E (Grid Ref. SS 8500 9175) where it terminates **and** divert that part of Footpath 58 commencing at Point A (Grid Ref. SS 8495 9184) and proceeding in a south south westerly direction for approximately 51 metres to Point B (Grid Ref. SS 8494 9179) where it terminates **to** a new section of footpath commencing at Point A (Grid Ref. SS 8495 9184) and proceeding south south westerly for 8 meters to Point F (Grid Ref. SS 8495 9184) then continuing along an already constructed path in a general south south-easterly direction for approximately 130 metres to meet the adopted footway at Point G (Grid Ref. SS 8500 9172) as shown on the order map.
