DEFINITIVE MAP MODIFICATION ORDER NO. 1 2025

This Order is made by the Bridgend County Borough Council ("the authority") under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Bridgend County Borough Council Definitive Map and Statement require modification in consequence of the occurrence of an event specified in Section 53 (3)(b) of the Act namely the expiration, in relation to any way in the area to which the map relates, of any period such that the enjoyment by the public of the way during that period raises a presumption that the way has been dedicated as a public path.

The authority have consulted with every local authority whose area includes the land to which the order relates. The Bridgend County Borough Council hereby order that:

1. For the purposes of this Order the relevant date is the date that the Order is made.
2. The Bridgend County Borough Council Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the Bridgend County Borough Council (Addition of Footpath leading from Dale View, Cefn Cribwr to Footpath 40 Cefn Cribwr) Definitive Map Modification Order No.1 2025

Modification of Definitive Map
Description of path or way to be added

The footpath commences from the junction with the maintainable highway at Dale View, Cefn Cribwr, Point A (Grid Reference SS 86418273), and proceeds in a general westerly direction for approximately 34 metres to its junction with Footpath 40 Cefn Cribwr at Point B (Grid Reference SS 86378275). The total length of the footpath will be approximately 34 metres.

The footpath has a width that varies and increases from 1.4 metres at its eastern end to 1.9 metres at its western end and is defined by the boundaries of Nos. 28 and 29 Dale View which abut the route and is shown between points A-B on the map attached to this Order

Width – 1.2 – 1.9 metres as defined by the boundaries of Nos. 28 and 29 Dale View which abut the route

Length – 34 metres

VARIATION OF THE PARTICULARS OF PATH OR WAY

The footpath commences from the junction with the maintainable highway at Dale View, Cefn Cribwr at Grid Reference SS 86418273, and proceeds in a general westerly direction for approximately 34 metres to its junction with Footpath 40 Cefn Cribwr at Grid Reference SS 86378275.
