## BRIDGEND COUNTY BOROUGH COUNCIL PORTHCAWL 10K RUN SPECIAL EVENT (VARIOUS ROADS, PORTHCAWL) TEMPORARY TRAFFIC ORDER 2025

**NOTICE IS HEREBY GIVEN** that the Council as the Highway Authority for Porthcawl in exercise of its powers under Section 16A of the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers intends in not less than 7 days from the date of this Notice to make an Order which will temporarily introduce the restrictions set out in the schedule below.
