PORTHCAWL 10K RUN SPECIAL EVENT (VARIOUS ROADS, PORTHCAWL)
TEMPORARY TRAFFIC ORDER 2025

NOTICE IS HEREBY GIVEN that the Council as the Highway Authority for Porthcawl in exercise of its powers under Section 16A of the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers intends in not less than 7 days from the date of this Notice to make an Order which will temporarily introduce the restrictions set out in the schedule below.

The Order is necessary due to the 10K annual running event taking place on the highway. The road closures are required to ensure the health and safety of those attending and working during the event and the residents in the surrounding area.

The Order will come into force on the 05th July 2025 and will continue in force until and including the 06th July 2025, or until such time the event is completed up to a maximum of 3 days. It is anticipated that the Order will be operative between the times as set out in the schedule below however times are likely to vary depending on the operational requirements of crowd control and safety during the event.
